

CONSENT, RELEASE AND WAIVER OF LIABILITY

GAINSBOROUGH CLUB, INC.

PLEASE READ CAREFULLY AND COMPLETELY BEFORE SIGNING

I grant permission for my child (print name) _____, whom I represent to be aged 10 or older, (hereinafter "qualifying child") to appear and remain at the Gainsborough Club, Inc. (hereinafter referred to as the "Pool") without the presence of a parent, guardian or other person to supervise their activities at the Pool. I am attaching a photo sized no larger than 2x3 or forwarding a digital photo of the qualifying child for use as identification at the Pool. The word "staff" as used herein, shall include all coaches, agents, officers, directors, employees, lifeguards, and parent volunteers of the Gainsborough Club, Inc.

I and my qualifying child understand that unchaperoned use of the Pool is privilege available only to those who display the maturity and discipline appropriate to allow the continued enjoyment of the Pool area by others. We understand and agree that the qualifying child must abide by all Pool rules while at the Pool (which the Undersigned acknowledges have been explained) and must follow the instructions of all staff while at the Pool. The failure to do so will result in consequences which may include but are not necessarily limited to restriction from entering the pool for the qualifying child or for others until the conduct is rectified, contact to the qualifying child's parent, guardian or responsible member, immediate dismissal or expulsion of the qualifying child from the Pool area, suspension of the privilege of use of the Pool without a chaperone, parent or adult supervision for all or a portion of the Pool season, or other consequences deemed appropriate to the circumstances. In the event immediate dismissal or expulsion is deemed appropriate, efforts will be made to contact the parent or guardian using the emergency information on file, and until the parent or guardian directs otherwise, the qualifying child may be directed to sit outside or just inside the fence area until pick-up arrangements can be made. The retention or re-gaining of the privilege of unchaperoned Pool use may also be subject to Board review or conditioned upon the completion of restitution (monetary or sweat equity), repairs, maintenance, clean up or other conditions as specified by the Board.

I grant permission for my child to be photographed for purposes of publicity, marketing or social media. I understand and consent to the use of photographs in local newspapers, The Gainsborough Club, Inc. website, newsletters or future brochures or other similar uses.

If any illness, injury or accident occurs which, in the sole judgment of the staff requires immediate medical attention, I give my consent for any member of the staff to obtain emergency treatment. I further understand that in the event of an emergency medical situation I will be notified as soon as possible, and consent to the signing of any releases by any member of the staff that may be required by any medical care provider to proceed in my absence. I understand that the cost of any medical treatment deemed necessary for treatment of any emergency illness, injury or accident occurring while my child is participating in Pool activities is my responsibility, and that the Gainsborough Club, Inc., their members individually, their officers, directors, agents, lifeguards, coaches and employees are not obligated to pay for such medical care.

I understand that my qualifying child's presence at the Pool will involve physical activities, including but not limited to swimming and diving. I understand and agree to assume any and all risks associated with such activities. I grant permission for my child to participate in such activities. For the sole consideration of the Gainsborough Club, Inc. allowing my child(ren) to appear and remain at the Pool without the presence of a parent, guardian or other person to supervise their activities at the Pool, I hereby release and forever discharge the Gainsborough Club, Inc., their members individually, their officers, directors, agents, lifeguards, coaches, employees and staff from any and all claims, demands, rights and causes of actions of whatever kind that I may have either arising from or by reason of any personal injury or property damage resulting from or in any way connected with my child's presence and/or activities at the Pool.

I further covenant and agree that for the consideration stated above I will not sue and will indemnify and hold harmless the Gainsborough Club, Inc., their members individually, their officers, directors, agents, lifeguards, coaches or employees for any claim for damages arising or growing out of my child's presence and/or activities at the Pool, excepting only those resulting from the sole negligence or intentional conduct of the indemnified parties.

I agree to provide the staff with emergency contact numbers and information and to keep the information current.

I have received a copy of this document and I certify that I am at least 18 years of age and have the legal right to execute this for myself and on behalf the qualifying child named herein and have read the above carefully before signing.
